RESOLUTION OF THE BOARD OF TRUSTEES OF PACIFIC VIEW CHARTER SCHOOL APPOINTING KIRA J. FOX AS AN INTERIM DIRECTOR OF BUSINESS AND OPERATIONS

Government Code Section 21221(h)

Resolution Number: 7 FEBRUARY 7, 2023

WHEREAS, Government (Gov.) Code section 21221(h) of the Public Employees' Retirement Law permits the governing body to appoint a CalPERS retiree to a vacant position requiring specialized skills during recruitment for a permanent appointment, and provides that such appointment will not subject the retired person to reinstatement from retirement or loss of benefits so long as it is a single appointment that does not exceed 960 hours in a fiscal year; and

WHEREAS, the Pacific View Charter School Board of Trustees desires to appoint Kira J. Fox as an interim appointment retired annuitant to the vacant position of Director Business and Operations for the Pacific View Charter School under Gov. Code section 21221(h), effective February 9, 2023; and

WHEREAS, the Board of Trustees of Pacific View Charter School and Kira J. Fox certify that KIra J. Fox has not and will not receive a Golden Handshake or any other retirement-related incentive; and

WHEREAS, an appointment under Gov. Code section 21221(h) requires the retiree is appointed into the interim appointment during recruitment for a permanent appointment; and

WHEREAS, the governing body has authorized the search for a permanent appointment on January 25, 2023; and

WHEREAS, this Gov. Code section 21221(h) appointment shall only be made once and therefore will end on upon filling of vacant position and

WHEREAS, the entire employment agreement between Kira J. Fox and the Pacific View Charter School has been reviewed by this body and is attached herein; and

WHEREAS, the compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties; and

WHEREAS, the maximum base salary for this position is \$203,122 and the hourly equivalent is \$102.00; the minimum base salary for this position is \$118,186 and the hourly equivalent is \$60.00; and

WHEREAS, the hourly rate paid to Kira J. Fox will be \$102.00; and

WHEREAS, Kira J. Fox has not and will not receive any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate; and

THEREFORE, BE IT RESOLVED THAT the Board of Trustees hereby certifies the nature of the employment of Kira J. Fox as described herein and detailed in the attached employment agreement / contract / appointment document and that this appointment is necessary to fill the critically needed position of Director of Business and Operations for the Pacific View Charter School by February 9, 2023 because of the resignation of the current Director of Business and Operations effective February 8, 2023
